1. Handling of Personalized Data

As a matter of course, you can visit our web pages without us collecting your personalized data. Personalized data is only collected if you communicate it to us for carrying out a contract, for opening a customer account or when contacting us. All of the personalized data is as a matter of course treated confidentially, and your interests worthy of protection are strictly protected according to the statutory provisions. Without your explicit consent, your personalized data is used exclusively for contract processing and for dealing with your inquiries. After complete processing of the contract, your data is stored according to fiscal and commercial retention periods but is blocked for all other uses; it will be deleted after expiration of these deadlines unless you have expressly consented that your data may be used further.

Personalized data is also collected when you sign up for our e-mail newsletter. This data is used for our own advertising purposes in the form of our e-mail newsletter if you have explicitly consented to it as follows: *"Please inform us regularly via e-mail about our product line. I can unsubscribe your newsletter anytime."* You can unsubscribe the newsletter anytime via the link in the newsletter provided for this purpose or via a message to us. After your deregistration, your e-mail address is immediately deleted from our newsletter distribution list.

For our own advertising purposes, we reserve the right to store the following data in collective lists and to use it for sending out interesting offerings and information about our products via letter post: Your first and last name, your postal address, and if we have obtained the respective information via a contractual agreement with you, also your title, your university degree, your date of birth and your professional, industrial sector or business designation. You can contradict the storage and use of your data for this purpose anytime by a message to the contact address described below.

In the context of contract processing, the personalized data collected by us is handed over to the transport company in charge of the delivery insofar as required for delivering the goods. For processing payments, we transmit your payment data to the credit institution in charge.

When you access us, our servers store data for statistical purposes. Even if this data can be used for identification there will be no personalized evaluation.

To protect the integrity of your data during transmission, we use an HTTPS-based encryption method according to the current state of the art.

2. Cookies

To make a visit to our website attractive and to enable the use of particular functions, we use so-called cookies on several web pages. These are small text files that are stored on your end device. Some of our cookies are deleted after the termination of the browser session, i.e. upon closing the browser (so-called session cookies). Others remain on your end device and enable us or our partner enterprises to recognize your browser during your next visit (persistent cookies). You can program your browser so that you are informed about the placement of cookies and can decide on a case-to-case basis whether or not to accept them, or you can exclude the acceptance of cookies for certain cases or in general. If you do not accept cookies, the functionality of our website may be restricted.

3. Google Analytics

This website uses Google Analytics, a web analysis service of Google Inc. ("Google"). Google Analytics uses so-called "cookies", text files that are stored on your computer and enable an analysis of the use you make of the website. The information about your use of the website created by the cookie is usually transmitted to and stored on a Google server in the USA. If the IP anonymization of this website is activated, then within the European Union as well as in other countries that have signed the Agreement on the European Economic Area, your IP address will first be shortened.
